- Conduct detrimental to ATK Golf Professionals and Tashua Knolls Golf Course
- Use of alcohol or illegal drugs
- Gambling
- Abusive language or profanity
- Displays of temper involving throwing or slamming bags, balls, clubs, or other equipment
- Cheating
- Abuse of Facilities
- Poor golf etiquette
- Use of golf carts, unless the players are being shuttled between holes of at the discretion of officials
- Breach of the USGA rules of golf

Any breach of the above guidelines on conduce will result in:
